Ride the back roads of Gilchrist County to work up an appetite and a need to jump in a cool spring. Time your arrival for gate-opening at 9 am if you will be doing a ride from Hart Springs. Food is planned for noon. The club will provide a main course; bring side dishes, salads, and deserts, and a lawn chair. PLEASE RSVP if you are going to eat the main course. Use the link in the event email, or click the button in the Members Area on the web site.

Entry into Hart Springs is \$4 per head (\$2 seniors), max \$12 per car. If you are arriving by bike, please stop and pay (those doing rides from the park don't have to pay to get back in).

Depending on where you are coming from in Gainesville, it can take up to an hour to drive to the park, which is southwest of Bell. Take SR 24 west from Gainesville (Newberry Road). In Trenton, turn north (right) onto US 129. After around 3 1/2 miles, turn west (left) onto CR 344. At CR 232, turn right and after half a mile left to remain on CR 344. The park is on the right before you get to the end of the road.

Gainesville Cycling Club's MS Team Gainesville alone, raised \$12,580.00 towards finding a cure and helping people who are living with Multiple Sclerosis in the Florida, St. Augustine – Bike MS PGA Tour Cycle to the Shore event and we had a great time doing it! This year, Team Gainesville is regrouping to ride again! We are participating in the FLN 2011 Bike MS PGA Tour Cycle to the Shore which will be held October 1st and 2nd, 2011. We will start and finish at St. Johns County/St. Augustine Airport.

The Bike MS: PGA TOUR Cycle to the Shore is a cycling adventure in which participants' ride 150 miles for two days of fun, fitness, networking, developing friendships and most importantly a great cause. On March 15th, members of the Gainesville Cycling Club spoke in favor of the Multi-Modal Transportation Mitigation Program before the Alachua County Commission. While the details of this program are quite technical, an end result of its implementation will be (among other things) increased funding for bike lanes in Alachua County.

The meeting itself was long and difficult. We had twenty-four GCC members in attendance at the start of the scheduled two hour session. Well over three hours into the meeting, the public was allowed to speak, and only nine of us remained. The Commissioners did notice our presence, and given that more than half the crowd left before speaking time, we continued to have the largest presence except for the developers (who were on our side regarding the issue at hand). The Commission unanimously approved to move forward with public advertisement and further consideration of the multi-modal plan that will, if approved, increase connectivity between transit, bicycle, automobile, and foot traffic.


If you are unfamiliar with politics, this meeting was frustrating. But in the end, we won. Listening to the discussion, many of us wondered what this meeting had to do, if anything, with bike lanes. All the talk was about developers fees and confusing impact issues. Well, those fees are what pays for bike lanes, bus routes, sidewalks, and potential rail transit needed to handle the increased traffic generated by new development. Impact fees are levied so that general taxes on existing properties (that's the ones we live in) do not have to be used to support new development. That is the connection, even though explicit transportation and connectivity issues were mentioned only late in the meeting. Developers have been a part of this planning process for all four years, whereas we have only just arrived. It is natural that their issue (money out of pocket) will get a lot of attention, but in the end they did

support passing the plan.

The Commissioners, staff, and engineers knew we were there and thanked us for bringing our members out. The Tea Party and anti-government people also knew we were there, and many of them left well before our cycling club members. The people who don't like bicycles were there as well. In the end, however, we heard a few fleeting voices speak out against buses, or against government in general. But the developers, home builders, cycling advocates, transportation engineers, county staff, planners, and others came out roundly in favor of moving forward with considering the multi-modal plan. Not one speaker said anything negative about bike lanes.

Many of you were disappointed and believed the meeting was stretched out purposefully to discourage our participation. Keep in mind that the whole county was watching, and it is important for elected officials to show their constituents due diligence in questioning methodology, staff advice, and other issues. A wise man once said, all you can ask of politics is that the meetings are short, and victory. One out of two isn't bad.

The single agenda item for the evening was to direct County staff to forward the multi-modal transportation plan to the public in the form of advertising. The frustrating thing was that the Commissioners began debating that plan, instead of asking that it merely be forwarded for consideration. In the end, however, we got what we wanted, and we got it in part because you cared to show up and be seen and heard.



- Adventure Cycling

The Gainesville Cycling Club is becoming more involved in the political process as issues affecting our use of the road are brought before governing bodies.

The hottest issue currently on the table is the design of the project to repave NW 16th Ave/Blvd. Our position, which was recently endorsed by the Gainesville City Commission, is that there should be 4 foot bike lanes striped on the roadway. This will leave room for two 10 foot lanes for other vehicles (a bit wider than the typical width of lanes on NW 6th St).

Ten foot lanes should slow down traffic (which typically travels at 50 mph despite the 40 mph limit) and move the traffic further away from the sidewalks. The only cost involved is for the paint for the additional lane line.

We will need good participation from our members when this issue is next brought up before the Alachua County Commission. Those who believe that bicycles should be relegated to sidewalks, and that automobiles should have plenty of room to go fast, have been very vocal at past meetings.


